From the Network Director:

It has been our privilege to continue delivering exceptional care to Veterans and their families. Earning and maintaining their trust is an essential part of our work, which has continued to improve. In 2023, 92% of Veteran patients reported they trust VISN 8 for their medical and mental health needs. Quality of care, satisfaction with specialty care, and interactions with staff were among the most complimented areas.

In 2023, the new PACT Act was implemented to expand VA health care eligibility for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War, and post-9/11 eras. More than any other network, VISN 8 screened nearly 500,000 Veterans for toxic exposures. Plus, more than 28,000 Veterans were newly enrolled in VA health care, a 26 percent increase from 2022.

In keeping with VA's priority to prevent Veteran suicide, VISN 8 partnered with more than 80 hospitals to host sessions about the Veterans Comprehensive Prevention, Access to Care, and Treatment Act (COMPACT Act). This law allows any Veteran in acute suicidal crisis to visit any VA or non-VA health care facility for emergency mental health care at no cost to them. Under this Act, nearly 9,000 Veterans in our service area received life-saving, emergency care, with many now receiving ongoing care and support.

The VISN 8 Clinical Contact Center (CCC), also called VA Health Connect, will celebrate its fifth anniversary this year as it continues to provide virtual urgent care around the clock to hundreds of thousands of Veterans. The center continues to experience significant growth in its service capabilities, technological advancements, and staffing levels.

We are pleased to report the opening of seven new or renovated facilities, with four more scheduled to open in 2024. These facilities offer new and expanded health care services, including women-specific services. Important work also continues on building a diverse workforce and an inclusive work environment.

Our nation's heroes receive exceptional care due to the unwavering commitment and dedication of our staff, volunteers, and partners. Thank you all!



Veterans Integrated Service Network (VISN) relative to Veterans served.



VA provides care to Veterans through community providers when VA cannot provide the care needed, or when care cannot be provided timely. Community care is based on specific eligibility requirements, availability of VA care, and the needs and circumstances of individual Veterans. Since 2021, VISN 8's use of care in the community has increased by nearly 46 percent, and in 2023 alone over 261,000 Veterans received some type of care from community providers paid for by VA.


VA provides comprehensive women's health services to include general health and wellness checks, women-specific care for reproductive health, management of longterm conditions, pain management, mental

Veterans by Age




Virtual Care Workload

Serving Veterans with Toxic Exposures



The Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act of 2022, known as the PACT Act, is perhaps the largest health care and benefit expansions in VA history. Several sections of the law were implemented in 2023 including expanded VA health care eligibility for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War, and post-9/11 eras. Additionally, VA will provide toxic exposure screenings at no cost for all Veterans enrolled and eligible for VA's medical benefits package.

VISN 8 led the nation in toxic exposure screenings and new VA health care enrollments. We held hundreds of community outreach events across Florida, South Georgia, Puerto Rico, and the U.S. Virgin Islands where thousands of Veterans learned more about the new law and many of whom received a toxic exposure screening and enrolled for VA health care.

In 2023, our health care professionals screened nearly 500,000 Veterans for toxic exposures – the most for any network in the country. Forty-one percent of those screened reported exposure concerns and were subsequently referred for diagnostic testing and treatment for their conditions. In addition, 28,103 Veterans were newly enrolled for VA's medical benefits package in 2023 within VISN 8 – a 26 percent increase in enrollments from the previous year. Preventing Veteran Suicide



Suicide has no single cause and no one approach can end it—but prevention is possible, especially when Veterans find support before a crisis happens and get care and treatment without delay.

In 2023, we partnered with the Florida Hospital Association to host an hourlong education session for more than 80 hospitals across the state about the Veterans Comprehensive Prevention, Access to Care, and Treatment Act (COMPACT Act). Signed into law in 2020 and fully implemented by VA in January 2023, the law allows any Veteran in acute suicidal crisis to visit any VA or non-VA health care facility for emergency mental health care at no cost to them.

Veterans do not have to be enrolled in VA health care to receive mental health emergency care. However, they must meet at least one of the following criteria:

- Veterans discharged from active duty under conditions other than dishonorable after a period of at least 24 months of active service
- Veterans who served more than 100 days under a combat exclusion or in support of a contingency operation, who were discharged under conditions other than dishonorable
- Veterans who were the victim of a physical assault of a sexual nature, a battery of sexual nature, or sexual harassment while serving in the armed forces

Under the COMPACT Act, VA will provide, pay for, or reimburse for treatment of eligible Veterans' emergency suicide care, transportation costs, and follow-up care at any VA or community health care center for up to 30 days of inpatient care and 90 days of outpatient care. Additionally, VA will make follow-up care referrals and determine eligibility for other VA services and benefits.

According to VA's 2023 National Veteran Suicide Prevention Annual Report, between 17-18 Veterans die each day from suicide, and the majority of which did not receive mental health care from VA. This data underscores the importance of VA collaborating with the community to advance access to necessary support and services to ensure Veterans get the right care when they need it the most.

In 2023, nearly 9,000 Veterans within our service area who experienced an acute suicidal crisis received lifesaving, emergency care under the COMPACT Act. Many of these heroes are now receiving ongoing care and support with VA along with the more than 193,000 who trusted VISN 8 facilities for their mental health needs last year. We know for every death by suicide approximately 135 people are impacted. For the nearly 9,000 Veterans who were in suicidal crisis and received care, there are 1.2 million individuals who did not have to experience the loss of suicide.





The Right Care. Right Now.

The VISN 8 Clinical Contact Center (CCC), also known as VA Health Connect, had another successful year in 2023 while providing virtual urgent care to hundreds of thousands of Veterans residing in Florida, Georgia, Alabama, South Carolina, Puerto Rico, and the U.S. Virgin Islands.

The center will celebrate its fifth anniversary in July 2024, and is the nation's premiere, around-the-clock, virtual urgent care provider offering a full complement of services to include nurse triage, pharmacy, scheduling and administration, and virtual visits with a doctor or nurse practitioner. The CCC team utilizes phone, VA Video Connect and VA Health Chat to engage with Veterans. Both VA Video Connect and VA Health Chat are secure apps Veterans can use at no cost to connect with providers for their nonemergency health care needs.

Since the center's inception, it has grown exponentially relative to service capabilities, technological advancements, and staffing levels. Over the last three years alone, telephone calls received by the center have increased by 84 percent, or from about 2 million calls in 2021 to 3.7 million calls in 2023. During the same period, virtual medical appointments completed, and pharmacy cases handled greatly increased by 90 percent and 159 percent respectively. The VISN 8 Clinical Contact Center is also a leader in the use of VA Health Chat. Since implementing the application in March 2020, secure chat volume has increased by an astounding 262 percent.

In 2023, the center's top accomplishments included:

- Implementation of the VA Health Connect Relationship Management for Clinical Triage Platform

 a national system used
 by registered nurses to improve Veteran experience

 and clinical documentation
- Improved primary care scheduling practices centered on Veteran preference
- Increased use of VA Video Connect for virtual care appointments by 10 percent over the last year. Approximately 32 percent of all virtual care appointment completed by the center in 2023 were done using VA Video Connect – VA's secure videoconferencing app. This app is designed to help Veterans quickly and easily meet with VA health care providers through live video on any device with an internet connection.

To contact the center 24/7/365, Veterans enrolled and eligible for care in VISN 8 and their caregivers may call 1-877-741-3400. Veterans can also download VA Health Chat at no cost from the Apple App or Google Play stores. Clinical Contact Center staff can respond to chats Monday – Friday from 8:00 a.m. – 4:00 p.m. weekly except for on federal holidays.

The VISN 8 Clinical Contact Center should not be used for emergency situations. For life-threatening emergencies, Veterans should dial 911 or visit their closest emergency department. To find the nearest emergency or urgent care center, visit www.va.gov/find-locations.

For non-emergency conditions that do not require a face-to-face visit, the VISN 8 CCC is available to serve America's heroes. To learn more, visit





In August 2023, and for the second time in 11 months, the Bay Pines VA Healthcare System activated emergency operations to prepare for the potential impact and aftermath of a hurricane headed for the southwest coast of Florida. In the span of 24 hours, 146 Veterans were evacuated to Orlando, West Palm Beach, North Florida/South Georgia, and Tampa VA Medical Centers to ensure their safety and continuing care during Hurricane Idalia. Thanks to the support from Florida Department of Veterans Affairs (FDVA), an additional 16 Veterans were also admitted to the FDVA's State Veteran Nursing Home in Orlando. "I believe that none of us is as good as all of us, and this past week validates that," said Bay Pines VA Director/CEO Paul M. Russo. "From the coordination and partnership throughout VISN 8 to our partnership with FDVA, we remain, as we always have been, an interwoven network of professionals who will always rise to the challenge to ensure the care, safety, and well-being of our nation's heroes."



Innovation Initiatives that Spread Nationwide

The Tampa VA invested in innovation strengths such as 3D printing, virtual reality, and artificial intelligence and as a result, was selected to become one of nine new VHA Innovator Network (iNET) sites for fiscal year 2024. Nationally, two highly successful initiatives - THRIVE and the VHA-Uber Health Connect were selected to be implemented nationally throughout the VA via iNET. In addition, the facility's Caregiver THRIVE program was awarded \$900K in national grant funding to serve rural caregivers in hard-to-reach areas. Lastly, the Tampa VA's rehabilitation team provided extensive education in both VA and private rehabilitation facilities on its Pain Empowerment Anywhere Program.



Women Veterans in Good Hands at Tampa VA

The Tampa VA continues to provide first class-service to all women Veterans. In 2023, VA celebrated 100 years of delivering health care to women Veterans. The facility celebrated with outreach events to add to the women Veteran roster and spread the word on new programs that are tailored to the needs of the group. The facility's Women's Center has expanded to become a level 3 Women Veterans Comprehensive Health Care Center with its own unique building entrance and a family-friendly waiting room. Women Veterans are assigned to teams that follow the Patient Aligned Care Team (PACT) model for health care delivery that includes primary care, gynecology, psychiatry, psychology, social work, pharmacy, nutrition, nursing, and administrative services. Eighty-eight percent of women Veterans seen in primary care are assigned to a Designated Women's Health PACT Team. The Tampa VA continues to move women's care forward with an increased focus on creating healthy families.



Tampa VA Makes Positive Impact on World Stage

Globally, the Tampa VA impacted change internationally by hosting a delegation of Ukrainian health care professionals for a weeklong summit and follow-up visits from a contingent that included the Ukrainian Deputy Minister of Veterans Affairs and other officials. The purpose of the series of visits was for the delegation to learn from Tampa VA experts about traumatic brain injury, spinal cord injury, and amputation during wartime.

The Miami VA Healthcare System is a Joint Commission accredited, complexity level 1A facility serving approximately 60,000 Veterans in three South Florida counties: Miami-Dade, Broward, and Monroe. The Bruce W. Carter VA Medical Center is in downtown Miami and supports two major satellite outpatient clinics located in Sunrise and Kev West, and five communitybased outpatient clinics located in Homestead, Key Largo, Pembroke Pines, Hollywood, and Deerfield Beach. The facility provides general medical, surgical, and psychiatric services, as well as serving as an AIDS/HIV center, prosthetic treatment center, spinal cord injury rehabilitative center and geriatric research, education, and clinical center. A health care for homeless Veterans clinic is located about one mile from the medical center. The organization is recognized as a Center of Excellence in spinal cord injury research, substance abuse treatment, and chest pain. The healthcare system also operates a robust research program.

New Stateof-the-Art Hemodialysis Clinic

The Miami VA Healthcare System opened a new, state-of-the-art hemodialysis clinic offering enhanced treatment options aimed at enhancing quality of life, health, and vitality of America's Veterans. The clinic's skilled medical professionals. cutting-edge technology, and compassionate approach ensure that every Veteran who walks through the doors receives the care they've earned and deserve. The new clinic space is over 13,200 square feet and includes new water treatment facilities and stations for preforming dialysis procedures.





Raising Awareness of Suicide Prevention

In September 2023, the Miami VA Healthcare System's William "Bill" Kling Clinic hosted a Suicide Prevention Awareness Day event attended by over 500 Veterans. VA Under Secretary for Health, Dr. Shereef Elnahal, headlined the event and provided words of encouragement as he addressed how the VA is providing support and resources for Veterans struggling with emotional and mental health issues. He emphasized in detail the interventions being provided throughout VA that have saved Veterans' lives and spoke at length about what it takes to keep making progress to stop Veteran suicides. Dr. Gloria Lewis, Suicide Prevention Coordinator, shared with Dr. Elnahal best practices being implemented throughout the Miami VA Healthcare System that help connect Veterans to needed mental health services and reduce the number of attempted and completed suicides. A total of 20 resource tables were set up by community and internal programs which provided the Veterans and their loved ones with valuable information and connections to VA and community support.



Raising Awareness of the PACT Act

In 2023, the Miami VA Healthcare System held several community outreach events to educate and inform Veterans and their loved ones of the PACT Act, perhaps the largest expansion of benefits in the history of VA. Some of the larger events were held in Miami, Homestead, and Sunrise giving Veterans the opportunity to learn about the new law, enroll for VA health care, apply for non-medical benefits, and more. The Miami VA plans to continue conducting similar outreach events to reach as many Veterans as possible in 2024 and beyond.

Malcom Randall VA Medical Center Upgrades Intensive Care Units

The Malcom Randall Veterans Affairs Medical Center implemented Continuous Venovenous Hemofiltration (CVVH), or hemodialysis, throughout its Intensive Care Units, the first of which was administered in June 2023. Through a concerted effort of various staff, the medical center is now equipped with the VA National Surgery Office and Cardiothoracic Surgical Advisory Board's recommended medical infrastructure.



Mako Robot Enhances Outcomes of Orthopedic Surgeries

The North Florida / South Georgia Veterans Health System and Malcom Randall VA Medical Center completed its ninth robot assisted lower extremity joint replacement utilizing a MAKO Smart Robotics Assisted Surgery System in August 2023. While robotic assisted surgery has been around for years, the implementation of its use at the Malcom Randall VA Medical Center has further demonstrated the innovation and advancement provided to our Veterans. The innovative robotic technology allows surgeons to personalize total knee, partial knee, and total hip replacement procedures to each Veteran. The robotic-assisted surgery represents the newest major technological advancement in hip and knee reconstructive surgery. Mako procedures significantly enhance the precision of both the necessary bone cuts and the placement of the prostheses in their ideal anatomic landmarks to a degree not possible with the conventional methods.



Health System Surpasses 200 Robotic-Assisted Bronchoscopy Procedures

The North Florida / South Georgia Veterans Health System's Malcom Randall VA Medical Center have achieved a landmark milestone surpassing 200 roboticassisted bronchoscopy procedures for Veterans throughout the system's service area in 2023. Robotassisted bronchoscopy is a recent advancement in navigational bronchoscopy, a procedure used to biopsy lung nodules to detect the presence of lung cancer and other lung diseases.

New Program Offers Innovative Approach to Mental Health Treatment

In 2023, the Orlando VA rolled out a new somatic treatment program aimed at helping Veterans with mental health disorders that have been traditionally difficult to treat. The program uses non-pharmacological techniques such as Electroconvulsive Therapy and Repetitive Transcranial Magnetic Stimulation along with Esketamine and Ketamine Infusion Therapies.



New Eyecare Program

The Orlando VA Healthcare System hosted a ribbon-cutting ceremony in June 2023 at the Lake Baldwin VA Clinic in Orlando, Fla., for its new Technology-Based Eye Care Services Program (TECS). This groundbreaking technology-based program is designed to increase access to care and improve Veteran convenience and satisfaction through the utilization of a mobilized medical unit that will travel to the Lake Baldwin, Clermont, and Kissimmee VA Clinics and provide screening availability to low-risk Veterans for cataracts, macular degeneration, glaucoma, and diabetic retinopathy. The mobilized medical unit will also provide Veterans with the option to pick out new frames for spectacle prescriptions.



Exoskeleton Makes a Huge Impact in Veterans Lives

In 2023, the Orlando VA implemented an innovative new treatment option for Veterans with spinal cord injuries and related disorders called Indego Therapy. This therapy is a lower-limbpowered exoskeleton that enables therapists to deliver task-specific, over-ground and individualized gait training. The device is worn around the waist and legs giving Veterans the ability to stand and walk, offering a new level of independence.

Veterans in the southern part of the island enjoyed refreshments and live music while enrolling in VA health care, filing claims, and learning about other VA and community programs.



Governor of Puerto Rico Joins Governor's Challenge

Last year, the Honorable Pedro R. Pierluisi, Governor of Puerto Rico, joined the Governor's Challenge to Prevent Suicide Among Service Members, Veterans, and their Families. The challenge is a collaborative effort between the Substance Abuse and Mental Health Services Administration (SAMHSA) and VA to bring the initiative to states, territories, and communities across the nation. The goal of the Governor's Challenge is to implement plans to prevent suicide and advance VA's National Strategy for Preventing Veteran Suicide. Puerto Rico became one of 54 states and territories taking part in the challenge when the Governor of Puerto Rico signed on in 2023.



New Local Partnership Aims to Prevent Veteran Suicides

In 2023, the VA Caribbean Healthcare System signed a collaborative agreement with Sistema de Salud Menonita (SSM) to develop and implement suicide prevention strategies and mental health services for Veterans, service members, and their families in the Caribbean region. The partnership was implemented within SSM's Hospital Menonita CIMA division and is expected to expand over time. Growing and cultivating long-lasting community partnerships is one way the VA Caribbean Healthcare System is working to tackle VA's top clinical priority – preventing Veteran suicide.
